

EVENT REPORT - IIDC BAKU, AZERBAIJAN 2022



On 26th August 2022, the International Diplomat's Conference was organized at Baku, Azerbaijan by a joint collaborative effort of Teaching Pakistan and Voice for Rights International Association Canada. The 3 day event focused on three major themes i.e. International Law and Justice, Freedom of Speech, Drugs education and Global economic instability. The main idea behind this international event was to gather social activists from different communities and vast backgrounds and collectively provide them with the opportunity to discuss the root causes of these issues and find means to tackle these matters.

During Day 1 of the conference, a city tour was organized for the participants with the aim to help everyone break the ice, interact with one another and relax. In this manner, the participants got the opportunity to explore the mesmerizing capital of Azerbaijan along with indulging in the unique local cuisines and visit the popular tourist attraction points including the Highland Park, Mini-Venice, walk around the Martyrs' lane, explore the Azerbaijan Carpet museum. Meanwhile, upon sundown, the group of participants explored the old Baku city and appreciated the ancient architecture within the region. Thus, the adventurous day 1 of the conference ended with an exquisite dinner at a local famous restaurant.

Day-2 of the event started off with the introductory session from the organizers, for this purpose Mr. Syed Kazam, Founder of Voice for Rights International was invited to give opening remarks. Mr. Kazam enlightened the participants regarding the main objective and purpose behind forming this Youth empowering organization. In addition, Mr. Usama Tariq founder of Teaching Pakistan gave his opening remarks depicting the main ideology of the organization as well as future aspirations. As follows, the host Ms. Dinora initiated the session and requested all the participants to introduce themselves after which, the conference officially commenced. The day was broken into two major keynote sessions followed by panel discussions on the themes involved. Mr. Saad Khan, a leading economist in UAE was invited to present regarding the Global Economic instability and Trade, his talk enlightened the participants regarding the basic understanding of economics, the major role of Small Medium Enterprise and how innovative methods can be utilized to distribute limited resources for greatest improvement of the business. The session ended with an in-depth discussion amongst the participants regarding the impact of economic change on the small businesses and the need to adopt innovative practices to save their businesses.

Secondly, after the lunch, the next honorable speaker session was conducted by the Director of Drug Free World Ms Christine Latam. During the virtually held session Christine's talk focused regarding the silently increasing concern of drug abuse amongst the youth globally and her talk emphasized on the urgent need to enhance drug education and awareness particularly amongst the Youth. For her session, each participant received an individual booklet designed by Drugfreeworld.org to educate and acknowledge the participants regarding different form of drugs and means through which they are exploited. Moreover, she highlighted the long-term implications of drugs and their impact in depressing the Central nervous system, reducing memory, affecting the ability logically think along with enhancing the risk of cancer development. All the participants were keen to learn more on this topic and thus, at the end of the talk a detailed Query session was conducted to discuss ideas and strategies that can reduce the inclination of the youth towards drugs. The take home message from this session was to start from grass root level and educate children regarding the negative implications of drugs through family discussions. In this manner, Day 2 ended with media interviews of the participants and group pictures were taken after which, the participants were free to have recreational time. For this purpose, the first session was conducted by Ms. Zoya Hamza the Founder of SHE a Non-Profitable Organization founded to empower women. During the interactive session, Ms. Zoya inspired the participants to analyze and embark the journey of Self-discovery, to understand their purpose as well as duty to the community. Furthermore, Zoya also highlighted the need to Freedom of Speech as well as portrayed the concept of "Gender equity" and its necessity within the community to build healthy connections.

Moreover, the next session was conducted by Dr. Noor Hayat Faculty of Mass communication who focused on Freedom of speech within various aspects of the society.

Dr. Noor's presentation explained the concept of free speech and associated this concept on a broader state level depicting the lack of Free speech within mass media, concept of free speech with religious perspective and how it is perceived globally. This session received the most interest by all the participants as well as panelists who discussed the future of free speech globally.

Lastly, Mr. Malik Azaz presented on the theme of International Law and Justice. Mr. Azaz's session involved a mock trail to discuss Whether Free trail existed within Pakistan or not, for this purpose the participants were divided into two blocks who counter argued on the topic. The mock trail involved heated discussions within the two teams and finally, the panel declared the team A which agreed on the topic as winners due to the quality of discussions and validity of arguments presented. After the conference, Spotlight sessions were conducted during which the Participants from Azerbaijan, Pakistan and UAE highlighted their personal experience of the conference, presented their future aspirations and conveyed their gratitude for getting the opportunity to participate in the prestigious event.

At last, the award ceremony was conducted followed by the ending remarks from the organisers. Moreover, on the basis of the quality of discussion, six participants were selected as the Partially funded delegates for the upcoming youth leadership training program intended to occur in the USA in 2023, While one participant was awarded with the title of Best Delegate and selected as a fully funded participant for the training program.

This 3 days event enabled social activists to understand and form solutions for implementing the UN-SDGs in our own country, while focusing on their applicability on national level, controversies and issues that pertain to this phenomenon and lastly, understand the root causes of global economic instability, lack of freedom of speech as well. This international conference not only helped participants to gain strong communication skills to convey their perspective within a crowd but also exposed them to a unique cross-cultural experience. Believed that the entire speaker sessions organized in this conference empowered and inspired all participants to work on individual levels to break the society's stereotypes through the power of free speech but also advocate the right for education on every level. Given that the participants in the conference belonged from diverse professional fields, this event enhanced individual understanding regarding then need for innovation, user psyche in economic and need for drug education which are not commonly discussed.
